Ordinance #0610 - 2003 (Replaces Ordinance # 98-0407)

An Ordinance Relating to Stop Signs /Yield Signs on Red Cedar Town Roads

The Town Board of the Town of Red Cedar, Dunn County, Wisconsin, do ordain as follows:
Stop signs and yield signs located at intersections of the town roads in the Town of Red Cedar as listed in this ordinance are necessary for safe traffic flow and may be enforced by law enforcement agencies of the County of Dunn and the State of Wisconsin: Stop signs include:

1. On 708th Ave. (Main Street) at 540th Street (Pine Point Road)
2. On 705th Ave. (W. Harrington Street) at 540th Street (Pine Point Road)
3. On 554th Street (E. Harrington Street) at 708th Ave. (E. Cedar Falls Rd) in both directions.
4. On 554th Street (E. Harrington Street) at 711th Ave. (School Street)
5. On 557th Street (Dow Rd) at 708th Ave. (E. Cedar Falls Rd.)
6. On 674th Ave. (Park View) at 530th Street (W. Cedar Falls Rd.)


Yield Signs include:

2. 538th Street at 691st Ave. (Park Rapids Rd.)
3. 700th Ave (Croftwood loop) at 564th Street (Meadowvale)
4. 704th Ave. (Sun Meadow Ct.) at 564th Street (Meadowvale)
5. 450th Ave. at 470th Ave. (Tanglewood Rd.)
6. 370th Ave. (Beaver trail Rd) at 570th Street (Church Rd.)


Penalties for failure to stop or yield at said signs are determined by the State of Wisconsin.
