

**TOWN OF RED CEDAR**  
**ORDINANCE No. 0808 - 2005 (Replaces Ordinance #0609 - 2003)**

**An Ordinance Relating to Speed Limits on Red Cedar Town Roads**

The Town Board of the Town of Red Cedar, Dunn County, Wisconsin, ordains as follows:

**Speed Limits:** Speed limits established by Section 346.57 Wisconsin Statutes are decreased as hereinafter set forth upon the following streets and avenues or portions thereof:

A. 45 MPH ZONES:

1. 530<sup>th</sup> Avenue (West Sunrise Road) from County Road E to 610<sup>th</sup> Street.
2. 510<sup>th</sup> Avenue (Whispering Hills Road) from 610<sup>th</sup> Street to CTH J.
3. 430<sup>th</sup> Avenue (Purple Martin Road) from 610<sup>th</sup> Street to CTH J.
4. 640<sup>th</sup> Street (Cedarview Road) from 420<sup>th</sup> Avenue to CTH J.
5. 708<sup>th</sup> Avenue (Cedar Falls Road) from CTH B to 564<sup>th</sup> Street.
6. 550<sup>th</sup> Street (Lookout Road) from 510<sup>th</sup> Ave. to city limits
7. 720<sup>th</sup> Avenue (Cedar Valley Road) from 720<sup>th</sup> Ave to 740<sup>th</sup> Street.

B. 40 MPH ZONES:

1. 490<sup>th</sup> (Bountivale Road) from 610<sup>th</sup> Street to CTH J.

C. 35 MPH ZONES:


1. 560<sup>th</sup> Street / 690<sup>th</sup> Ave. / 550<sup>th</sup> Street / 680<sup>th</sup> Ave. (Boat Landing Road) from 700<sup>th</sup> Ave. South
2. 650<sup>th</sup> Avenue (Eagle Point Road)


D. 25 MPH ZONES:


1. 689<sup>th</sup> Avenue (Cedar Drive)
2. 564<sup>th</sup> Street (Meadow Vale Road)
3. 708<sup>th</sup> Avenue (Cedar Falls Road) from 564<sup>th</sup> Street to CTH BB.
4. 690<sup>th</sup> Avenue / 684<sup>th</sup> Avenue / 558<sup>th</sup> Street (Briarcliff Road)
5. 627<sup>th</sup> Avenue (Anna Street)
6. 560<sup>th</sup> Street (Boat Landing Road) from 708<sup>th</sup> Avenue to 700<sup>th</sup> Avenue
7. 547<sup>th</sup> Street (Ceci Lane)
8. 600<sup>th</sup> Street (Rain Street)
9. 483<sup>rd</sup> Avenue (Egan Drive)

This ordinance shall repeal any previous board action on speed zones and take effect upon passage and publication as provided by law.
