

**Town of Red Cedar**  
**Ordinance #0312 - 2007 (Replaces Ordinance # 0610-2003 & 98-0407)**

**An Ordinance Relating to Stop Signs /Yield Signs on Red Cedar Town Roads**

The Town Board of the Town of Red Cedar, Dunn County, Wisconsin, do ordain as follows:  
Stop signs and yield signs located at intersections of the town roads in the Town of Red Cedar as listed in this ordinance are necessary for safe traffic flow and may be enforced by law enforcement agencies of the County of Dunn and the State of Wisconsin: Stop signs include:

1. On 708<sup>th</sup> Ave. (Main Street) at 540<sup>th</sup> Street (Pine Point Road)

This ordinance shall repeal any previous board action on stop signs and yield signs and take effect upon passage and publications as provided by law.
