The Town Board of the Town of Red Cedar met on Thursday, April 28, 2016, at 4:30 p.m. at the Town Hall in Rusk, E6591 627th Avenue, Menomonie, WI.

<u>Call to Order</u>: The Road Inspection meeting was called to order by the Chairman. Business:

- 1) The board members left the town hall to inspect town roads at 4:32 p.m.
- 2) The road inspection was completed at 7:33 p.m., and board members commenced the meeting at the Exit 45 Restaurant Meeting Room in Menomonie. The Clerk, Cheryl Miller, attended this portion of the meeting. Items of note discussed and/or acted upon are documented below:

The Town Board discussed fund availability for road projects and requested that these projects be reviewed at the May, 2016 monthly board meeting.

Road Projects to Complete This Year

- 1) 708th Avenue, 1.76 miles, from Co. Road B to Co. Road BB: wedging, both sides; 1.5 inch overlay; town will widen one corner and shoulder by mailbox. Proposal by Scott Construction: \$135,000.00.
- 2) 578th Ave./600th St.: double chip seal. Proposal by Scott Construction: \$12,500.00.
- 3) 567th St. (off 490th Ave.), Southfields: dig down and put in drain tile; gravel for one year. Proposal by Wachsmuth Excavating: \$12,500.00.

Projects for Consideration

Paver Patching Needs

- 1) 610th Street, 4 places.
- 2) 640th Street (Beyer Settlement Road), 2 places.
- 3) 690th Street (Twin Hill) 3 places, needs paver patching, possible cold mix paver patch.

- 1) 574th Street (1st road to left on 780th Ave.).
- 2) 670th Street (Cottonwood) to Co. Rd. E, rough chip seal.
- 3) 740th Street.

- 1) 450th/470th Avenue (Tanglewood).
- 2) 533rd St. (dead end west of BB).
- 3) 571st Ave.
- 4) 610th Street (after paver patching).
- 5) 650th Avenue (North Rusk), Wildcatter.
- 6) 690th Street (Twin Hill), after paver patching.

- 7) 765th Street (Iron Creek) after paver patching.
- 8) 720th Ave., cold mix paver.
- 9) 680th Ave. (Swamp Road), paver patching.
- 10) 560th St.
- 11) Boat Landing Road, after ditching corners.
- 12) All Cedar Falls roads.

Culvert Replacements

- 1) 420th Ave., fix ditch at same time, water runs down road most of the way down the hill.
- 2) 490th Ave. (by Bob Cook's).
- 3) 510th Ave. (by Buckley's), culvert is failing, culvert sunk, trim trees.

- 6) 610th Ave. (both sides of Co. Rd. E).
- 7) 640th St. (Grimm's).
- 8) 730th St. (South Ney), STH 12/29 to Co. Rd. E, grader patch on corner.
- 9) 691st Ave., shoulders by culvert.

- 1) 370th Ave. (Klatt's Driveway).
- 2) All of Timber Ridge needs shouldering.
