(565th Street)

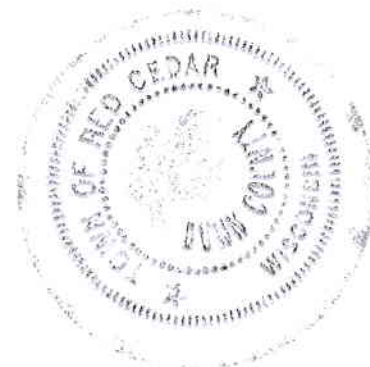

RESOLUTION ACCEPTING DEDICATION OF TOWN ROADS

The Town Board of the Town of Red Cedar, Dunn County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and declares as follows:

The public way to be dedicated to the town is described as 565th Street in the Southfields First Addition Subdivision and is accepted pursuant to Sec. 66.1024, Wis. Stats.

The Southfields First Addition (Being a Replat of Lots 10-12, Southfields) Subdivision project plat, design plans and specifications for construction were approved by the Town of Red Cedar and Dunn County prior to the current requirement for a developer's agreement and current requirement for execution and approval of a Town Acceptance/Rejection of New Town Road/Engineer Certification document, and acceptable construction and improvements have been made to that road, said roadway being located in the Town of Red Cedar, Dunn County, Wisconsin, as set forth in the Southfields First Addition Subdivision Plat approved by the Town Board and signed on November 20, 2007 and recorded in the Office of the Registrar of Deeds for Dunn County, Wisconsin as Document No. 549431 on December 19, 2007.

It is in the public interest that the dedication of the public ways described above is accepted by the town.

The town clerk shall properly post or publish this resolution as required under s. 60.80, Wis. Stats.
