RESOLUTION #1006-2012 ADOPTING REVISED PUBLIC SERVICE CHARGES

WHEREAS, the Town Board previously approved the establishment of public service charges; and

WHEREAS, the Town Board has not adjusted the majority of the town's public services charges since 2006; and

WHEREAS, the operating costs of town services have increased substantially since 2006; and

WHEREAS, the Town Board finds that it is reasonable and necessary to increase the public service charges to residents and vendors to the levels provided in this resolution;

NOW, THEREFORE, BE IT RESOLVED that the following public service charges shall be established, effective upon adoption of this Resolution, and shall apply to all public services provided by the Town of Red Cedar on and after November 1, 2012:

**Delivery Charges:** (gravel, base course, salt, sand, etc.)

Large truck: \$75.00 per delivery

\$ 85.00 non-resident delivery

Small Truck: \$65.00 per delivery

\$75.00 non-resident delivery

Culverts: \$75.00 per delivery

*Deliveries that require more than one hour of time will be billed additional charges.*

**Plow and sand subdivisions:** \$75.00 per hour; 1 hour minimum charge (Timber Ridge, Emerald Ridge, etc.).

**Plow and sand driveways:** \$75.00 per hour; ½ hour minimum charge. *Red Cedar will plow snow for residences in extreme situations only.*

**Tractor (loader, mower, snow plowing):** \$80.00 per hour plus labor charges; 1 hour minimum charge.

**Grader:** \$100.00 per hour plus labor charges; 1 hour minimum charge.

**Labor for Town employees:** \$32.50 per hour includes use of chainsaw, shovels, truck (to and from site), etc.

**Rates for other items will be made on a case-by-case basis by the Town Chairman or the Town Board.**

*If applicable, additional charges may apply for materials, sales tax, non-resident surcharge, etc.*




