TOWN OF RED CEDAR ORDINANCE RELATING TO STOP and YIELD SIGNS ON TOWN ROADS

ORDINANCE NO.: 2019-6 (Replaces Ordinance No.: 0312-007, 0610-2003, & 98-0407)

It is hereby ordained by the Town Board of the Town of Red Cedar, Dunn County Wisconsin, as follows:

Section 1 - Purpose and Intent

The purpose and intent of this Ordinance is for the Town of Red Cedar to regulate stop and yield signs in the Town of Red Cedar.

Section 2 - Authority

The Town Board of the Town of Red Cedar has the specific authority under s. 349.07 (8), Wis. Stats., and general authority under its village powers under s. 60.22, Wis. Stats., to adopt this ordinance.

Section 3 - Adoption

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides stop and yield signs on certain town highways in the town as follows:

Section 4 - Stop and Yield Sign Placement

A. Pursuant to s. 349.07(8), Wis. Stat., stop signs shall be placed on Town of Red Cedar town highways as follows:
