Ballots will be cast for the office of Justice of the Supreme Court (vote for 1: J.C. Protasiewicz, D. Kelly); Town Board Chairperson (vote for 1: B. Cook); Town Board Supervisor 1 (vote for 1: E. Hendrickson); Town Board Supervisor 2 (vote for 1: J. Richartz); School District Members as follows: Menomonie (vote for not more than 3: S. Parker, A. Riddle-Swanson, C. Schneider, B. Weiker, D. Dahlke, A. Kersting); or Colfax (vote for not more than 3: K. Bjork; J. Kiekhafer, J. Ackerlund, D. Solberg); or Elk Mound (vote for not more than 3: K.M. Lombard, T. A. Koser, T. Siverston). The following State Referendum questions will also be submitted to a vote of the people pursuant to law: QUESTION 1 – "Conditions of release before conviction. Shall Section 8(2) of article I of the constitution be amended to allow a court to impose on an accused person being released before conviction conditions that are designed to protect the community from serious harm?" - QUESTION 2 - "Cash bail before conviction. Shall section 8(2) of article I of the constitution be amended to allow a court to impose cash bail on a person accused of a violent crime based on the totality of the circumstances, including the accused's previous convictions for a violent crime, the probability that the accused will fail to appear, the need to protect the community from serious harm and prevent witness intimidation, and potential affirmative defenses?" - QUESTION 3 - "Shall able-bodied, childless adults be required to look for work in order to receive taxpayer-funded welfare benefits?" The polls will be open at 7:00 a.m. and close at 8:00 p.m. Our polling place is accessible to elderly and disabled voters. The number of outstanding provisional ballots will be posted at the town hall on election night.
